ANNUAL HOMEOWNERS MEETING MINUTES
September 23, 2017

The Annual Homeowners Association meeting was called to order by Sean Abbott, at 1:05 p.m. the meeting was held on site at the Cottonwood Court, court yard at 5873 S. Prince Street, Littleton, Colorado

The homeowners were welcomed to the annual meeting, and introduced the Board of Directors and the Management Co.

Management certified that the annual meeting and proxy were sent to each homeowner of record on September 8th, 2017, via general mail.

A quorum was established with homeowners attending and signing the Annual Meeting sign-in sheet or via proxy, that are in good standing with the HOA.

Minutes from the Annual Meeting held September 17 2016 were included with the packet to the homeowners, a motion was made by Sean Abbott and seconded by Sue Ocker to accept the minutes as submitted, and the motion was approved unanimously.

ACCOMPLISHMENTS 2017: A report of the 2017 accomplishments was submitted, and asked for homeowners input and any questions or additions.

GOALS & OBJECTIVES 2018: A report of the 2018 Goals & Objectives was submitted, and asked for homeowner input and any questions. or additions.

FINANCIAL REPORTS: Management reported on the YTD financial conditions of the HOA, balance sheet has \$32,393.61 in the checking account, and \$34,152.99 in the reserve account, for a total of \$66,546.60 through August 31, 2017. YTD 2017 expense comparison with 2016 expenses have decreased by \$6,159.76. 2018 Budget and Reserve Budget were discussed. Copies of YTD financial reports. Balance sheet and budgets were included with the homeowners annual meeting package. A copy of the Reserve Analysis Estimate work sheet was also included with the meeting packet. The Board recommended not to increase the 2018 HOA maintenance fees, future project and improvements are subject to funds available for each future project

2018 BUDGET: The 2018 budget highlighted in yellow column, was discussed and each line item was reviewed. The 2018 HOA monthly maintenance fee will remain the same as 2017 with no increase, the last increase in monthly maintenance fees was 2008.

ELECTIONS: The meeting was then opened for nominations for the Board of Directors position. There were two open positions. A motion was made by Sean Abbot to retain Sue Ocker and Ed Clint for another 3-year term, the motion was seconded by Merle McKittrick, the motion was approved unanimously to retain Sue Ocker and Ed Clint for (3) three-year terms.
